
**\*AFFIDAVIT\*** No-3445/23

I, Nikhil Ranjan, Principal of Vidya Vihar Residential School, solemnly affirm and declare as follows:


- \* I am the duly appointed Principal of Vidya Vihar Residential School, located at Parora, Purnea.
- \* I am authorized to make this affidavit on behalf of the school.
- \* It is my responsibility to ensure that the certificates issued by the state government department contain all the relevant information as required in the prescribed format of the Central Board of Secondary Education (CBSE).
- \* The CBSE is a national-level educational board that sets the standards and guidelines for schools in India. It has a specific format for certificates from schools
- \* However, the state government department responsible for issuing certificates to Vidya Vihar Residential School has their own format, which differs from the prescribed format of the CBSE.
- \* Despite our repeated attempts and requests, the state government department has not entertained our efforts to obtain the certificates in the CBSE format. They have consistently maintained that their own format is the only acceptable format for issuing certificates to the school.
- \* As a result, it is not within our control or authority to obtain the certificates in the CBSE format.
- \* We have made every reasonable effort to comply with the CBSE guidelines, but the state government department's refusal to accommodate our requests has made it impossible for us to do so.
- \* I hereby affirm that the certificates issued by the state government department do contain all the relevant information required by the CBSE guidelines, to the best of my knowledge and belief.
- \* While the format may differ, the essential details are included in the certificates issued by the state government department.
- \* I further affirm that this affidavit is made for the purpose of ensuring that the certificate issued by the state government department will be recognized and accepted by the CBSE, even though it may not conform to the CBSE format.
- \* I declare that the above statements are true and correct to the best of my knowledge and belief.
